Ms. Devin Hartzler

Devin Hartzler MSN, FNP-C, ACHPN, is board certified as a family nurse practitioner (FNP) with additional hospice and palliative care certification as an Advanced Certified Hospice and Palliative Nurse (ACHPN). She has had sixteen years of nursing experience, starting her career as a diploma-trained licensed practical nurse (LPN). She has since moved her way up the nursing career ladder obtaining her associate's degree in nursing (ADN), bachelor's degree in nursing (BSN), and master's degree in nursing (MSN). She has worked in a variety of settings including long-term care, acute care, primary care, and hospice. Realizing the importance of quality of life, as well as a passion for caring for end-of-life patients, she has dedicated the past 10 years of her career in the hospice realm, initially as a hospice registered nurse (RN) and now as a hospice nurse practitioner (NP). She is an End-of-Life Nursing Education Consortium (ELNEC) trainer through the American Association of Colleges of Nursing (AACN). She currently resides in Indianapolis, Indiana, and works full-time as a hospice NP with Community Hospice.



Dr. Sherry Jimenez

Sherry Jimenez, EdD, CHCP, CHSE, FNAOME, serves as the associate dean of IPE and simulation at LMU-DCOM in Harrogate and Knoxville, Tennessee. She is responsible for administrative and operational oversight of the Center for Interprofessional Education and Simulation (CIPES) comprised of simulation and training facilities including the American Heart Association (AHA) Training Center. Together with her dynamic team, she supports clinical training and improvement activities in undergraduate, graduate, and interprofessional education including but not limited to collaboration with medical, physician assistant, nursing, veterinary, and allied health programs. Dr. Jimenez is board vice president for the Tennessee Interprofessional Practice and Education Consortium (TIPEC), a fellow of the National Academy of Osteopathic Medical Educators (NAOME), and a certified health care simulation educator (CHSE).



Dr. Veera Motashaw

Veera Motashaw, DO, HMDC, is a dual board-certified physician in family practice and hospice and palliative medicine who graduated from the Edward Via College of Osteopathic Medicine in Blacksburg, Virginia. Postgraduate she completed a family medicine residency at Wake Forest University in North Carolina and then went on to complete a fellowship in hospice and palliative medicine. Dr. Motashaw served as a hospice physician and medical director in Indianapolis, Indiana, prior to moving to Tennessee, where she practiced across many clinical settings including in-patient, external care facilities, outpatient clinics, and home visits. Dr. Motashaw has presented at national conferences and teaches courses in the Biodynamic Model of Osteopathy in the Cranial Field. Dr. Kellee Harper-Hanigan

Dr. Kullgren is also the immediate past president for the Society of Pain and Palliative Care Pharmacists.



Mr. Randall Tingle

Randy Tingle, MDiv, is supervisor of pastoral care at Ft. Sanders Regional Medical Center (FSRMC) in Knoxville, Tennessee. As well as supervising the pastoral care team of FSRMC including four chaplains both in full-time and PRN status, Mr. Tingle is a practicing clinician in patient care. Mr. Tingle also recruits, trains and supervises 40 pastoral care volunteers in the Stephen Ministry Program at FSRMC. In addition to his involvement with supervision and patient care he is the coordinator of the FSRMC ethics committee; The leader of the WeCare program (an employee assistance program that raises and distributes \$100,000 per year); the leader of the NODA program (a program that Tingle developed to train and use volunteers to hold vigil with the dying); and a member of the palliative care, oncology, and cardiology IDT's. He is also a certified member of the IRB for FSRMC/TCSC. He earned his Master of Divinity from Duke University Divinity School, his bachelor's degree from Central Michigan University, and completed a CPE residency at UTMCK and Moses Cone Greensboro. He is an ordained United Methodist clergy member of the Western North Carolina UMC and has served four UMC congregations as senior pastor and three hospitals since 1993. Mr. Tingle is in process of becoming a board-certified chaplain with ACPE.
